Enrollment Agreement - Fees

I understand that occasionally there may be additional fees for field trips & activities. Initial _____

I understand that there is limited space. If we have reserved your space, there is not a reduction in fees due to sudden absences. Please try to give one at least week's notice. Initial _____

I understand that if I want to guarantee my child's space, a 1-week deposit is advised. It will be credited towards my account. I understand that priority of enrollment will be given to families seeking full-time/ full-Summer attendance. _____

Enrollment Agreement - Attendance

I understand that camp is in session Monday through Friday, except holidays. I can drop my child as early as 8:15 am. Camp ends at 3:15 pm and pick up must occur by 3:30 pm. After-Care starts at 3:35 pm and an automatic fee (\$10) will be charged for my child's participation should they still be present. After-Care ends at 5:30pm. If I am late, an additional \$1/minute will apply until I pick-up my child. Initial _____

I will ensure my child is well fed and well rested before arriving to camp. And they will be provided a nutritious (non-sugar) lunch. Initial _____

I understand that it is the policy of the Camp not to accept, or allow to attend camp, those students who exhibit the need for extensive disciplinary actions. The first two weeks of camp attendance is a probationary period. Initial _____

It is our experience and educational philosophy, at SAGE, that we are able to best help a child when they are not ingesting stimulants or tranquilizers. This also includes street drugs. We provide drug education during our academic-year session, but also ask that parents of children and teens keep an open conversation about the effects of drug use. Initial _____

If my child is ill / has a fever, I will not bring him/her to camp until they have been free of fever for 2 days (Or whatever the current county mandates). Should my child become ill during camp hours, I understand I will be contacted to pick him/her up and will do so promptly. Initial _____
